Council's last adjustment in fee income was more that 2-years ago April 18, 2018. With the increasing operating cost and devaluation of the Jamaican Dollar (April 18, 2018=J\$124.39, July 25, 2020=J\$146.50) there is now need for a rate adjustment to enable the Council to be financially sustainable and to continue to serve our several clients in an effective manner.
